Synopsis: On May 20, 2010, North Greenwood Neighborhood Patrol Officers were conducting an extra patrol in the North Greenwood Community when they observed a suspicious vehicle in the 1500 block of Harbor Drive. The officers observed the suspicious vehicle pull into the driveway of a previously identified abandoned residence, which also had a prominent no trespassing sign on the front wall. Contact was initiated. The driver, Jermaine Williams, exited the vehicle and proceeded to access the trunk area as officers approached. The officers issued verbal commands to Williams, who quickly shut the trunk and stepped away from the vehicle. The officers obtained a consent search of the vehicle and located an SKS Assault Rifle in the truck of the vehicle along with two loaded magazines. Williams was placed into custody for being a Felon in Possession of a Firearm. Detective responded and obtained a full confession from Williams and determined that all four occupants of the vehicle were convicted felons.
