At 7:08 a.m., Clearwater Officers were dispatched to a gas station at 2295 SR 590, where the victim called 911 for help following the shooting. The victim was transported to a local hospital where he was treated and released for non-life-threatening injuries.

The armed robbery and shooting occurred within a vehicle - a White 1997 Toyota Camry - at the Coachman Creek Apartments at 2625 State Road 590. The vehicle has been recovered and is being processed as evidence. The investigation continues....
