DENTIST RECOVERS STOLEN ITEMS; TWO ARRESTE WITH HELP FROM CRAIG'S LIST AD

SUMMARY: A burglary occurred sometime between 6 p.m. on 11/16/11 and 7 a.m. on 11/17/11 to Dr. William Strupp's Dental Office, 2376 Sunset Point Rd. The following items were taken:

2 x Mac computer with keyboards
3x Dell Laptops
Apple Mac Book Pro
2 Dell Monitor
2 large Video external Hard drives
Computer software on computer valued over \$5000, HP Printer all-in-one, Small Olympus camera
Bottle of Valium 100 qty, Bottle of Lorab 100 qty,
Sporting Memorabilia: two large diamond shape shadow boxes with 100 + baseballs signed by the NY Yankees, 3 baseball bats with multiple NY Yankee signatures, 1 Heisman football signed by multiple players

Portable X-ray machine, Air Abrader dental equipment, 2 Fuji S1 Pro cameras with extended lenses and external flashes, Nikon 35 mm, iPod Nano, Postage Machine

The estimated value (not included the memorabilia) is \$37,000.

During the course of this commercial burglary investigation, Clearwater Police Detectives met with the victim and discussed the possibility of listing his property on Craigslist in an effort to attract potential suspects. This was suggested by detectives because of the nature of the items and the thought that the stolen items could not easily be pawned.

Dr. Strupp set up a "Stolen Yankees" ad on Craigslist on 11/24/11 with photographs of the stolen items and a reward for their return. On December 22, 2011, Dr. Strupp received a phone call from an unknown mysterious subject stating that he had the memorabilia. The subject, Robert Kinzinger, further stated that if Dr. Strupp wanted the items he would sell them to him for a cost. Details were worked out where the two were to meet and the victim was to buy back half of his property for \$5,000.00. They were to meet at Sunset Point Road and U.S. 19 in the Publix parking lot. The meeting was to take place on Jan. 04 at 2 p.m.

A sting operation was set in place. Two vehicles were observed in the area and it was determined they were suspicious. One of the two suspects in the vehicle got out of a vehicle with several baseballs and two bats and started walking toward the victim's vehicle. This subject was apprehended and taken into custody; the second suspect drove away and was later stopped by other burglary detectives. During the detail two vehicles were seized and most of the sports memorabilia was recovered along with computers that belonged to Dr. Strupp.

Several other leads were fostered and an actual chain of events was recovered from the post Miranda statements and interview of Eson. On January 6, 2012 a search warrant was served and more of the dentist's property was recovered.
