SUMMARY: Clearwater Police Detectives with the assistance of Belleair Police Detectives were able to link five juveniles to the felony criminal mischief cases that occurred in the Carlouel Neighborhood in Clearwater Beach last month.

Early in the morning on April 17th, four unknown suspects entered the Carlouel neighborhood in a 1990's model Jeep Cherokee and threw approximately 60 golf balls multiple vehicles.
