## POLICE DEPARTMENT

**WHY:** On November 24, 2009, Clearwater Police responded to the Trinity Pharmacy for a reported armed robbery with shots fired. Upon arrival officers learned that as the victim exited the pharmacy, the suspect approached him. The suspect pointed a firearm at the victim and demanded his prescription medication. The victim attempted to run back into the pharmacy to avoid the robbery when the suspect discharged the firearm, striking the victim in the right leg. The bullet went through the victim's leg and entered the occupied pharmacy. No one else was injured. The victim was admitted to Morton Plan Hospital and was said to be in "stable condition."

Detectives followed investigative leads throughout the evening and were able to identify three suspects who were located and arrested without incident. They are currently booked in the Pinellas County Jail, facing multiple charges.
